REACH Self Declaration

REACH Candidate List of SVHC

Presswood International B.V. (Presswood) declares that its pressed wood products, including pallets and pallet blocks, are manufactured from recycled wood.

As recycled wood originates from various sources, the exact chemical composition may vary per batch. Presswood applies supplier controls and monitoring procedures to manage this variability. Presswood is in compliance with the REACH Regulation (EC 1907/2006) concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals.

Presswood monitors the REACH Candidate List of Substances of Very High Concern (SVHC), as published and updated by the European Chemicals Agency (ECHA). Presswood does not intentionally add any substances listed on the Candidate List of SVHC in the manufacturing process. Based on available raw material data, supplier information and internal evaluations, Presswood confirms that the articles supplied do not contain substances listed on the REACH Candidate List in concentrations above 0.1% (weight by weight) per individual article, in accordance with Article 33 of REACH. Therefore, no information obligations under Article 33 of the REACH Regulation apply to the articles supplied by Presswood International B.V.

Under the current legislation, the pressed wood products manufactured by Presswood are not subject to authorisation requirements under Annex XIV of the REACH Regulation. Presswood will continue to monitor official updates published by ECHA and will revise this declaration if required.
